Purpose:

The purpose of the NEPDA scholarship program is to promote membership in PDA by rewarding promising NEPDA New England Student Chapter members for academic achievement and contributions to the success of the Student Chapter.

Scope: The policy pertains to the NEPDA Student Chapter based at the Middlesex Community College (MCC)

### Procedure:

### I. Budgeting

- a. NEPDA will review the operating budget annually and determine the number of scholarships to award and the value of each. The line item must be approved by Chapter Board members by a vote taken in accordance with Chapter by-laws.
- b. Budgetary decisions should consider Global PDA Chapter Financial requirements and chapter goals.
- The approved allocation should be added to the chapter annual operating budget for submission to Global PDA in accordance with Chapter Financial Principles
- d. Scholarships greater than \$5,000 will require funds be held in a separate escrow account.
- e. The NEPDA President shall notify NEPDA Student Chapter President and Faculty Advisors of approved scholarship award(s) and post the information on the NEPDA website.
- f. Funds allocated to scholarships, but not awarded by 30 November of the scholarship year will be rolled back into the chapter's general funds.
- g. Applications for the approved scholarships shall be amended to this policy as approved attachments.

### II. Acceptance Criteria

- a. NEPDA will develop written acceptance criteria for the application process and incorporate into NEPDA Scholarship Application(s) which shall be amended to this policy as approved attachments.
- b. Blank Scholarship Applications will be provided to the NEPDA Student Chapter President and Faculty Advisors upon request and will be made available on the chapter website.
- c. NEPDA may review and revise the acceptance criteria from time to time, as they deem necessary.

### III. Application Process

- a. This completed scholarship application must be submitted along with the accompanying documentation to the NEPDA Chapter President by the cutoff date listed on the NEPDA calendar at <a href="http://pdachapters.org/newengland/">http://pdachapters.org/newengland/</a> and scholarship application. No applications will be accepted that are postmarked after the cutoff date.
- b. All submissions are final. Once the application is submitted, the applicant will not be provided the opportunity to make additions or revisions.
- c. Any willful falsification of data on this application will disqualify the applicant from consideration

### IV. Selection Process

- NEPDA President will compile all applications and supporting documents and forward copies to each Chapter Board member.
- b. Each Chapter Board member will review the applications, compare the application to the written acceptance criteria, and provide a written primary and contingent recommendation for each scholarship to the Chapter Secretary.
- c. The Chapter Secretary will count the recommendations and notify the Chapter Board in writing of the recipient and contingent recipient for each scholarship. Scholarships shall be awarded by majority vote of the Chapter Board. In the event of a tie, a second ballot will be conducted during a routine Chapter Board meeting. In either case, results will be certified by the Chapter Board in the minutes of a routine business meeting.
- d. Only one scholarship may be awarded per person per calendar year

e. NEPDA President will submit the names of scholarship recipients and supporting documentation to Global PDA for approval. The supporting documentation will include copies of applications, certified results, and meeting minutes from the business meeting where the results were certified. Approval is automatic unless PDA Global denies the award within 30 days of receipt.

### V. Award

- a. Scholarship awards will make a public presentation to the recipient at a routine dinner meeting and will provide Global PDA at least 45 days notice of the event.
- b. Scholarships will be paid by the NEPDA Treasurer directly to the bursar of the college or university with instructions to pay 50% in each of two installments corresponding to the start of the semester or at the beginning of the first and third quarters, as applicable.
- c. Recipients must continue to meet the acceptance criteria during the period detailed for each scholarship. Failure to comply will result in revocation of the scholarship.
- d. Revoked scholarships will be awarded to the contingent recipient for that scholarship.
- e. A scholarship recipient, who forfeits the scholarship because they do not attend school during the scholarship term, will be eligible to reapply.

Minimum Acceptance Criteria:

- a. Overall GPA of  $\geq$  3.0 (B) with a Science GPA of  $\geq$  3.5 (B+/A-) (copy of transcript required with application)
- b. A letter of recommendation by Mariluci Bladon or Paul Patev along with another letter from a different instructor(science or non-science)
- c. Sealed letter of recommendation from the Student Chapter President indicating good standing and participation status.
- d. PDA member for a minimum of one academic year.
- e. Participation in PDA activities including, but not limited to: Service as student chapter officer; Attendance at student chapter meetings; Attendance at NEPDA events such as business meetings or dinner meetings; Presentation of posters at NEPDA events; Other contributions to strengthening program

### New England Chapter of the Parenteral Drug Association Student Chapter Transfer Scholarship Application

The New England Chapter of the Parenteral Drug association will award no more than one member of the NEPDA Student Chapter a scholarship of \$5,000 towards completing their first year as a transfer student to a four year college or university.

The Student Chapter Transfer Scholarship was started in 2009 to award promising NEPDA Student Chapter members for academic achievement and activity promoting and strengthening PDA and the NEPDA Student Chapter.

### **QUALIFICATIONS:**

Applicants must be active members of the Parenteral Drug Association for a minimum of two academic years, have successfully completed the biotech course of study at MCC, and have been accepted to a full time, ABET-accredited baccalaureate program with a life sciences or engineering major. Selection is based on scholastic excellence and participation in chapter activities.

Minimum Acceptance Criteria:

- a. Overall GPA of ≥ 3.0 (B) with a Science GPA of ≥ 3.5 (B+/A-) (copy of transcript required with application)
- b. A letter of recommendation by Mariluci Bladon or Paul Patev along with another letter from a different instructor(science or non-science)
- c. PDA student chapter member for a minimum of two academic years
- d. A letter of recommendation from the Student Chapter President indicating good standing and participation status in chapter activities
- e. Participation in PDA activities including, but not limited to: Service as student chapter officer; Attendance at student chapter meetings; Attendance at NEPDA events such as business meetings or dinner meetings; Presentation of posters at NEPDA events; other contributions to strengthening program.
- f. Accepted as a full time student with a life sciences or engineering major at an ABET-accredited four year college or university
