**Refunds:** Refund requests must be made in writing. If received 12 weeks prior to the start of the event, 50% refund will be made, with a handling fee of € 200 per registration. After this period until 4 weeks prior to the start of the event NO REFUND will be made.

### *c. Cooperation.*

The Exhibitor and PDA Europe will assist each other in complying with their respective obligations under EU Data Protection Laws, including but not limited to, assisting each other with verifying the authenticity of Data Subjects or responding to Data Subject requests. To the fullest extent required by applicable law, the Exhibitor shall be responsible for providing notifications to, and respond to inquiries and requests from, the Data Subjects.

### *d. International Transfers.*

### *e. Restrictions.*

The Exhibitor shall not share the personal data of Data Subjects with any third parties, except for purposes of such third parties acting on behalf of the Exhibitor for Exhibitor's own business purposes.

### *f. Indemnification.*

The Exhibitor shall defend, hold harmless, and indemnify PDA Europe as to any third party's claims, actions, investigations, or other proceedings and related damages, injuries, awards, or other liabilities in connection with the Exhibitor's violations of its obligations under this Section (Attendee Data – EEA).

### *g. Contact.*

The individual signing the registration form as Exhibitor's representative shall be deemed to be the contact person for all data protection inquiries in connection with the personal data of Data Subjects being transferred hereunder.
